**CIO-SP3 Small Business is a \$20 billion, 10-year, Government -Wide Acquisition Contract (GWAC) for IT services/solutions that can be used by any federal civilian or DoD agency to fulfill IT requirements and socioeconomic goals.**

**Scope:** CIO-SP3 Small Business covers **everything IT<sup>SM</sup>** including cloud computing, security/cybersecurity, data center consolidation, biomedical information services, health IT, imaging, mobility solutions, software development, enterprise data management, systems engineering, identity and access management, ERP IT infrastructure, workforce management, capital planning and investment, and more.

**Quality:** NITAAC contract holders are rigorously vetted prior to award so you are assured of the highest quality responses. An experienced team of Contracting Officers and IT Specialists are standing by to respond to your questions within 1 hour.

**Ease:** End-to-end management is easy with NITAAC's secure, web-based electronic-Government Ordering System (e-GOS), that automates delivery order competition, awardee selection and notification. The contracting process is completely controlled by your agency's procuring CO, who can easily add customized terms and conditions at the task order level.
